Hawaii Foodbank and Aloha Harvest Donation Drive

The goal of the discussion, also moderated by Hannah Caddle, was to talk about how women can become more active in leadership in Hawaii in diverse areas, including the judiciary, legislature, private practice, and state commissions/boards. Legislative Outreach Update



The mission of Hawaii Women Lawyers is to improve the lives and careers of women in all aspects of the legal profession, influence the future of the legal profession, and enhance the status of women and promote equal opportunities for all. As part of this mission, Hawaii Women Lawyers monitors legislation at the State level that may impact the lives of women and families, and provides testimony relating to such legislation. For the 2021 legislative session, Hawaii Women Lawyers has or will be submitting testimony in support of the following bills:

HB 576 / SB 624 - Relating to Health Care. Authorizes advanced practice registered nurses to perform medication or aspiration abortions. **This bill was signed into law by Governor Ige on April 12, 2021.**

HB 1096 / SB 618 - Relating to Parentage. Requires the department of health to convene a task force to recommend amendments to the Hawaii Revised Statutes to update existing parentage laws that reflect outdated, cisheteronormative concepts of families, parenthood, and parental rights.

SB 193 / HB 1077 - Relating to Equitable Gender Representation On Corporate Boards. Requires publicly held domestic corporations to have a gender-diverse board of directors and establishes reporting requirements for the Department of Commerce and Consumer Affairs and penalties.

SB 827 / HB 564 - Relating to Breast Cancer Screening. Increases the categories of women required to be covered for mammogram screenings, requires the existing health insurance mandate for coverage of low-dose mammography to include digital mammography and breast tomosynthesis. Requires health care providers to be reimbursed at rates accurately reflecting the resource costs specific to each service, including any increased resource cost after January 1, 2021.

GM503. Submitting for consideration and confirmation as the Director of the Department of Human Services, Gubernatorial Nominee, Catherine Betts.

SR 8 - Relating to Convening Task Force to Address Implementation of Hawaii's State Law Corollary to Title IX to Strengthen Hawaii's Efforts to End Campus-Based Sexual Violence and Gender Discrimination. Task Force is requested to recommend amendments to Hawaii's state law corollary for the purpose of addressing potential conflicts between Hawaii's law and the federal government's recent changes to the Title IX regulations, while considering the possible impacts of any restoration by the new federal administration of prior Title IX protections, and to recommend a meaningful enforcement framework for Hawaii's state law corollary to Title IX.

HWL also submitted comments regarding **HCR 5 Relating to Establishing a Joint Committee on Judicial Selection**, the purpose of which is to establish a Joint Committee on Judicial Selection and to have the Committee work with the Judicial Selection Commission and the Judiciary to, among other things, “[c]reate greater transparency as to the rules and procedures applicable to the Judicial Selection Commission[.]” Currently, an applicant’s name is publicly released only upon nomination by the Commission for a vacant judicial position. The Resolution states that “Hawaii’s merit-based judicial selection process can only be preserved through public confidence and public confidence requires full disclosure of the process and the need for confidentiality as an inherent part of merit-based judicial selection.” HWL commented that it will be important for the different stakeholders and decision-makers to balance considerations of any need for full disclosure with considerations of the impact that such requirements may have on women applicants for judicial positions, as there may be concerns that publicly releasing information about an applicant may have a disproportionate negative impact on women who are considering applying.
